1) **SHOWS:**

A) JUDGES, EMT & FACILITY: Mylene has confirmed with both judges, Peggy Klump and Carolyn Lindholm as well as with Amanda Waterfield (EMT) Mylene has also confirmed with John Carapino that the facility will be groomed and ready for set-up on Saturday afternoon and that the City will furnish a generator to run the electrical needed for Sunday. Cynthia Collins has graciously offered to make her sound system available for any freestyle rides only requesting that the rider have the music on their cell phone, no CD's.

B) FOOD: Janet will contact Lynn Forester to pick up sandwich trays, a case of regular and diet sodas and bags of ice for the show lunch for volunteers. Tiffany has volunteered to pick up waters and chips and place into the trailer on Saturday set-up. Jessica has volunteered to pick-up donuts and coffee for the morning of the show.

C) HIGH POINT: It was decided to again give a ribbon to all High Point winners along with a certificate towards \$20.00 for a future Pomona Chapter show. Mylene will bring those certificates to the show on Sunday.

D) TRAILER: Tiffany will contact Anna Beal to ask her to haul the trailer back from the show to Yorba Linda to be store. Janet should contact Kris Hubbard to let her know in advance that we will be pulling the trailer out on Saturday 6/12 and returning it on the late afternoon/evening on 6/13.

E) VOLUNTEERS: Joanne will be sending out an email blast regarding the show and set up the Sign Up Genius for volunteers. Mylene will post another FB post regarding the same as well as the

show closing date. Tiffany will contact Dhana Holck to ask her to be scorer for the show. Mylene will reach out to Evalene Vu to volunteer as warm-up ring steward.

2)BANQUET/YEAR END: Mylene and Janet will go to Cedar Creek to see if dates are available for our year end banquet. First choice of dates will be Sunday, November 7, 2021, second choice, Sunday, November 14, 2021. The following prizes were discussed and Kim will research items, Tiffany suggested blanket bags, with feed bags as reserve prizes, all items to be embroidered as in past years.
