SHOWS:

Next Chapter show to be held on Sunday, April 11, 2021. Show Manager will be Jessica Gustin, Diana Muravez will be secretary. Judges have been confirmed as Melissa Creswick and Carolyn Lindholm. Mylene C. will reserve hotel accommodations for Judge Creswick.

Additional shows for 2021 are scheduled as follows:

June 13, August 1, and October 24. Discussion was held with regards to changing the currently scheduled October 24, 2021 All Hallow's Eve show to October 31, 2021 as there are currently other possibly conflicting larger shows on October 24<sup>th</sup> that might draw away participants in our show. A motion was made by Janet S. to therefore move the date to Sunday October 31, 2021. Motion was seconded by Lynn F. and all voted in favor, motion passed. Mylene will make arrangements to notify CDS central office and to hopefully coordinate current judges or hire new judges as necessary and to contact the City of West Covina to change the venue date.

Discussion was held with regards to the possibility of raising show fees. It was concluded that due to the current economy that raising show fees may result in less attendance and therefore less revenue. It was however discussed that an additional \$5.00 EMT fee could be added to our premium to cover the cost of the EMT required at all shows. Motion was made by Mylene C. to include a \$5.00 EMT fee on our premium beginning

with the April 11, 2021 show. Motion was seconded by Kim W., all in favor, motion passed.

Cynthia C. will handle the WDAA and CAWDA coordination for our shows. She will require that the premium be sent to her to post with WDAA a minimum of thirty days in advance. Upon receiving a show number from WDAA, Mylene C. or Lynn F. can then issue a check in the amount of \$25.00 for show recognition.

Cynthia C. brought to the Boards' attention that High Point prizes and ribbons are not separately given for the Western Dressage riders by division. Currently only one High point ribbon and prize for the Western Dressage riders is given. It was unanimously decided that High Point ribbons and prizes be awarded to Junior, Adult Amateur and Open riders in Western Dressage beginning at our April 11, 2021 show. Mylene C. will order additional required ribbons.

The Chapter trailer is in disrepair and it will be required that the repairs to the floor, roof and any additional areas be repaired as soon as possible. Tiffany B. will consult with her husband to see what can be done. She will report back to the Board and then the necessary arrangements for its repair will be made.

#### EDUCATION/CLINICS:

Tiffany B. would like to have a clinic with Gerhardt Politz upon things opening up due to Covid at this time any type of clinic may be difficult. An unmounted Pilates clinic is also something that may be possible upon the Covid situation allowing.

The Chapter needs to sponsor riders to the Junior Clinic and to the Adult Amateur clinics. A check in the amount of \$150.00 per clinic needs to be sent to CDS for our Chapter representatives. Mylene C. will publicize on the Facebook site, Joanne G. will send out email blast regarding these two events. Mylene C. will contact Laure W. to advise the webmaster to post it on our website and update the application accordingly.
