## **RULES AND INFORMATION**

All Pomona Chapter Dressage Shows and every class offered herein are covered by the rules and specifications of the current USEF Rule Book and will be conducted and judged in accordance therewith.

**ENTRY PROCEDURE:** Entries must be made on an official entry form and must be filled out completely, including all classes entered, all signatures, organization membership numbers and fees. Make copies of both sides if you need more than one entry form. Only one horse/rider combination per entry form. Please make checks payable to CDS-POMONA CHAPTER. Please be sure to put correct class numbers on entry form. Any entry errors will not be changed after closing date. **Please include a photocopy of current CDS membership card.** Entries are accepted on a first-come, first-served basis until classes are filled. All entries received after the closing date will be accepted only if schedule permits. Each late entry shall be assessed a late fee of \$35.00. Any entry changed after the closing date will be accommodated at Horse Show Management's sole and absolute discretion and will incur a \$35.00 change fee. Riders will ride with their classes, unless riding multiple horses, in accordance with Federation rules. Each competitor is responsible for supplying Horse Show Management with Rider's full name and CDS number; Horse's name; Owner's full name and CDS number; Trainer's full name; Coach's full name & copies of each applicable membership card, BEFORE the day of competition. The scores of competitors who fail to supply correct numbers may not be counted toward year-end awards (see CDS Omnibus).

**CONDITION OF ENTRY:** Every horse entered for competition will be under the control of the Horse Show Management, but the Horse Show Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show; its Directors and Employees, and CDS Pomona Chapter; its Directors and Employees, harmless for any loss or accident, to his horse, horses or equipment which may occur from accident, sickness, fire or otherwise.

**CLOSING OF ENTRIES:** Entries close and must be received by **October 19, 2023**, (the "Closing Date"). Entries are accepted on a first-come, first-served basis until classes are filled. All entries received after the closing date will be accepted only if schedule permits. Each late entry **received after October 19, 2023** shall be assessed a late fee of \$35.00.

**REFUSAL OF ENTRIES:** Horse Show Management reserves the right to refuse, accept conditionally, or cancel any entries of any exhibitors.

**REFUNDS:** A refund will be given for any reason until the Closing Date of the show. **Absolutely no refunds after the Closing Date.** Scratches or class changes accepted until closing date. Changes will incur a \$35.00 change fee and will be made only in the sole and absolute discretion of Horse Show Management.

**RETURNED CHECKS:** Checks returned by the bank for any reason will be charged an additional 10% penalty (\$25.00 minimum). Accounts will be given ten (10) calendar days to be paid in full with cash or cash equivalent or they will be turned into the Federation and/or CDS for further disciplinary action.

**RESPONSIBILITY:** All owners will be held responsible for any damage incurred by them, and their agents or employees, to buildings and other properties on the show grounds, and shall be handled accordingly.

**DISCIPLINE:** Exhibitors are warned that any act of discourtesy or disobedience to the officials of this show on part of the owner, exhibitor, agent, lessee, trainer, coach, groom, rider, handler or family of the above, will disqualify the horse from adjudication. The Horse Show Management reserves the right to remove a horse, owner, exhibitor, agent, lessee, trainer, coach, groom, rider or handler from the show without being liable for compensation or damages.

**MANAGEMENT:** The Horse Show Management reserves the right to interpret all questions and conditions in regard to or arising out of incident to the show without claims for damages or recourse of any kind. All questions not covered in these rules and regulations shall be decided by the Horse Show Management, with their decision to be final. The Horse Show Management reserves to itself the right to: refuse, accept conditionally or cancel any entries, disqualify riders or exhibitors, prohibit entries and cancel award prizes without claim for damages, cancel or combine any classes, reschedule classes and rotate judges in order to facilitate the time schedule.

**CANCELLATION:** In the event of rain or inclement weather prior to the show, it is the competitor's responsibility to call the Horse Show Management to determine whether the show is canceled. Shows are not canceled due to rain unless footing is deemed unsafe. If this show is canceled for any reason, a \$40.00 per day fee will be retained from each entry fee.

**SHOW OFFICE:** Exhibitors are encouraged to check-in promptly upon first arrival on the show grounds. The show office will be open approximately 1 hour before start of show and until approximately 1 hour after the last ride of the day. Horse Show Management can be reached at (657) 688-2032.

## **RULES & INFORMATION (continued):**

**TESTS:** Current USDF, USEF, and FEI tests will be used. FEI and Musical Freestyle are offered. Current WDAA tests will be used.

**SCORED TESTS** will only be distributed to riders, or their authorized representatives, after the results have been finalized and the awards presented.

**READING TESTS:** Reading tests is perfectly acceptable at our shows. However, we want to make sure everyone is safe and this includes our readers as well as our riders. After a few narrow misses with exuberant horses, we've decided that readers should be a MINIMUM of 6 feet away from any perimeter of the dressage court. Readers may stand near "E" or "B," but if two courts are present then the reader should stand OUTSIDE the fence as to be at least 6 feet away from the perimeter of the court.

**NUMBER OF TESTS:** Horses may compete in no more than one Recognized Competition on the same day(s) and are limited to a maximum of three Dressage rides per day at Fourth Level and below or two Dressage rides per day above Fourth Level. Dressage Seat Equitation and Materiale classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.

**RIDING TIMES:** Ride times will be available on the Chapter website [www.cdspomonachapter.org](http://www.cdspomonachapter.org) by the Wednesday of the week of the show. Please call Show Management for times if you are unable to access the website. Ride times will also be posted on the show grounds at the show office during the show. Be sure to check your times at the show office on the morning of the show to make sure nothing has changed.

**RIBBONS & AWARDS:** In each class, the first place winner will receive an award. Ribbons are given first to fifth place.

**JUDGES:** If for any reason a judge fails to attend the show or to perform his duties, the Horse Show Management reserves the right to substitute a judge for one who was officially designated in the Premium.

**JUNIORS:** All minors/juniors must be supervised by their parent/guardian or authorized agent at all times while at or on the show grounds, whether riding or on foot. The parent/guardian or authorized agent shall assume all responsibility to protect juniors from any injury, damage, harm and/or loss and shall identify, defend and hold CDS, USDF, USEF and Horse Show Management harmless there from. **All juniors must wear properly fitted protective headgear (ASTM/SEI) while riding anywhere on the grounds at any CDS, USDF, USEF recognized event. Harness must be secured and properly fitted.** It is the responsibility of the rider, or the parent or guardian of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards for protective headgear intended for equestrian use and is properly fitted and in good condition. Horse Show Management and licensed officials are not responsible for checking headgear worn for such compliance. CDS, USDF, USEF makes no representation or warranty, express or implied, that any protective headgear and cautions riders that death or serious injury may result despite wearing such headgear as all equestrian sports involved inherent dangerous risk and as such no helmet can protect against all foreseeable injuries.

**AMATEUR & JUNIOR CERTIFICATION:** Every person who has reached his/her 22nd birthday and competes in classes for amateurs under Federation rules must possess current amateur certification issued by the Federation. This certification must be available for inspection or the competitor must have lodged with the competition secretary, at least one hour prior to such class, an application for such certification provided by the Federation. Forms may be obtained from the Federation. Certification will be issued only on receipt of the application properly signed and is revocable at any time for cause. Any person who has not reached his/her 22nd birthday is a JRYR and does not require amateur certification. (See USEF GR1306 and GR1307) For purposes of competition in the Dressage Division: Individuals are eligible as Juniors until the end of the calendar year in which they reach the age of 18. Individuals are eligible as Young Riders from the beginning of the calendar year in which they reach the age of 22. Competitors shall compete as adults from the beginning of the calendar year in which they reach the age of 22. Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach the age of 22. (See USEF DR119.3) You must specify on the entry which section you are entered in A (Am) or J (Junior)/Young Rider (YR).

**UNRATED CLASSES:** CDS only recognized shows may offer unrated classes including but not limited to USDF Intro tests, USEA eventing tests and Western Dressage tests. The mandatory helmet rule shall apply. Riders and horse owners in unrated classes at CDS only recognized shows are exempt from the CDS non-member fee but must complete the CDS non-member information form.

**DRESSAGE SEAT EQUITATION:** Junior/Young Rider class open to those riders 21 years and under. Adult Amateur class open to adult amateur riders 22 years and older. This is a rail class. Multiple horses/riders will be in the ring together.

**PAS de DEUX:** Riders may compete in costume (boots and helmet still required) for this class only.

## RULES & INFORMATION (continued):

**STABLE AVAILABILITY:** No stabling is available at this show.

**SHARPS CONTAINER LOCATION:** The sharps container will be located in the show office.

**ARENA DIMENSIONS AND FOOTING:** Show arena is 20 m x 60 m. Warm-up arena is at least 150 ft x 80 ft. Footing consists of mainly sand, crumbled rubber, and DG in the show arena and in the warm-up arena. Only those horses entered in the show are permitted use of the show facilities, warm-up arena and show area. All horses in the warm-up arena must wear competition numbers. No lunging in the warm up arena.

**DOGS:** All dogs must be on a leash. No exceptions.

**PARKING:** Please note that only vehicles with horse trailers are allowed to park inside of the gates. All "solo" vehicles (that is, not hitched to a horse trailer) are asked to park outside of the gates nearest the show arena. There is a limited amount of available horse trailer space and we want our show to be safe and competitor friendly. In addition, we must have clear access for emergency vehicles. There is a limited amount of parking near the show office for those with special needs. Prior arrangements must be made with the Horse Show Management by calling (714) 993-7456. *Thank you in advance for your cooperation in making this a safe and competitor friendly show.*

**PROTECTIVE HEADGEAR: (Effective April 1, 2013) From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.**

## **2024 YEAR-END AWARDS QUALIFICATIONS:**

To be eligible for any Pomona Chapter Year End Awards, the rider must comply with the following:

- Be a Pomona Chapter active member in good standing at the time the scores are earned OR pay a nominating fee of \$35 to the Pomona Chapter. The nominating fee allows non-Pomona Chapter members to be eligible for year-end awards. The fee must be paid on or before the final show of the competition year (our Midsummer Days Dressage show).
- Donate four hours of volunteer service are required for each horse/rider combination ie) a rider showing 3 horses must have a total of 12 volunteer hours to be eligible for CDS Pomona Chapter Year End Awards. These hours can be obtained by donating time to volunteer/staff horse shows, being an elected member of the Board, being appointed to one of the numerous committees, or by providing \$100.00 cash donation (equivalent to four (4) hours of service) to the Chapter on or before of the final show of the competition year (our Midsummer Days Dressage show). Hours can only be donated to a rider by an immediate family member or the owner of the horse that is being ridden.
- The Champion horse/rider combination at any given level may NOT be won in two (2) consecutive years. The Reserve Champion horse/rider combination at any given level is eligible to compete for Championship at the same level in consecutive years.
- For Introductory through Fourth Level, the horse/rider combination must compete at a MINIMUM of two Chapter recognized shows and obtain a MINIMUM of three scores at the same level/division. For Prix St. Georges through Grand Prix, the horse/rider combination must compete in a MINIMUM of two Chapter recognized shows and obtain a MINIMUM of two scores at the same level/division. The scores will be averaged, and the highest percentage will be Champion, the second highest percentage will be Reserve Champion in each division, as described above.
- Dressage Seat Equitation Awards are available as Adult Amateur and Junior/Young Rider and based on RIDER ONLY. The rider must compete at a MINIMUM of two Chapter recognized shows and obtain a MINIMUM of two scores in the Dressage Seat Equitation classes offered at any Pomona Chapter recognized show. The scores will be averaged, and the highest percentage will be Champion and the second highest percentage will be Reserve Champion.
- Season High Score Awards are available to Open, Adult Amateur or Junior/Young Rider. Prior year Pomona Chapter Champion and Reserve Champion at a given level may win a Season High Score Award at the same level in successive years.
- Horse/rider combinations are only eligible for awards in consecutive levels (i.e. Training and First, but not Training and Second)

## USDF 2023 Regional Schooling Show Awards Program Rules

### General Information:

1. Program year is December 1 through November 30.
2. Scores must be earned in competitions participating in the program.
3. Scores may be earned in any USDF region.
4. Late nominations, scores and applications will not be accepted.

### Rider Eligibility & Requirements:

1. Rider must have a USDF Group Membership that is recorded by the Group Member Organization (GMO) at the time the scores are earned.
2. Riders affiliated with an International GMO must declare a USDF region.
3. There are no membership requirements for the owner of the horse and no USDF non-member fee is required. USDF Group Membership is only required for the rider.
4. Horse must have at least a USDF Horse Identification Number at the time the scores are earned.
5. Nominations of horse/rider combinations, along with the \$35 nomination fee, can be made at any time during the program year. The deadline to submit a nomination for the program year is **December 21, 2023 (after the 11/30 end of the program year)**.
6. Riders may change their division status during the program year. A rider's status will be determined at the end of the program year.
7. Riders must submit scores through the USDF website, and they may be submitted at any time during the program year. The deadline to submit a score for the program year is **December 21, 2023 (after the 11/30 end of the program year)**.
8. Results submitted by competition management are only used to verify scores submitted on the USDF website by the nominee.
9. Only USDF members in good standing are eligible to compete in the USDF Regional Schooling Show Awards Program and receive awards.

### Award Divisions & Levels:

1. Four award divisions will be recognized per region:
  - a. Open: from the beginning of the calendar year the rider reaches age 22, not a USEF Adult Amateur (AA), not a non-professional.
  - b. Junior/Young Rider (Jr/YR): up until the end of the calendar year the rider reaches age 21.
  - c. AA: from the beginning of the calendar year the rider reaches age 22 and possess a current USEF AA card.
  - d. Non-Professional: from the beginning of the calendar year the rider reaches age 22, not a current USEF AA, not a professional.
2. Seven levels (freestyle, pas de deux and quadrille not included) will be recognized per division. Exception: only 6 levels are recognized in the open division:
  - a. Introductory (only in Jr/YR, AA and non-professional divisions)
  - b. Training
  - c. First
  - d. Second
  - e. Third
  - f. Fourth

9. FEI – combination of Prix St. Georges, Intermediate I, Intermediate II and Grand Prix scores.
3. Equivalencies listed in the current *USDF Member Guide* are eligible. Tests not listed as equivalencies will not be eligible.
4. Preliminary standings will be ranked using a median of all eligible scores and will be available on the USDF website.
5. Final awards standings will be based on the rider's region of primary residence in the USDF database as of November 30.

### Score requirements:

1. Introductory Level:
    - a. Must have a minimum of three scores
    - b. From two different judges
    - c. From two different competitions
  2. Training through Fourth Levels (levels may not be combined to meet requirements):
    - a. Must have a minimum of three scores
    - b. From two different judges
    - c. From two different competitions
    - d. At least one score must be earned from the highest test of the level
  3. FEI Level (levels may be combined to meet requirements):
    - a. Must have a minimum of three scores
    - b. From two different judges
    - c. From two different competitions
- Prizes:**
1. Up to ten placings per division/level will be recognized.
  2. Ribbons will be mailed to the rider.
  3. Certificates will be available online.

### Competition Management Requirements:

1. Any non-USEF-licensed/non-USDF-recognized competition may participate.
2. To participate, competition management must submit online application and \$25 participation fee to USDF at least 30 calendar days prior to the start date of the competition.
3. The prize list must be submitted to USDF no later than 14 calendar days prior to the competition.
4. Competition management is prohibited from charging competitors a fee for their scores to be eligible for the USDF Regional Schooling Show Awards Program.
5. Competition judges must be one of the following:
  - a. Current USDF L Graduate, with or without distinction, which has met USDF continuing education requirements and Safe Sport training.
  - b. USEF or retired FEI dressage judge.
6. FEI classes must be judged by USEF or retired FEI dressage judges or USDF L Graduates with distinction.
7. Competition arenas must be in compliance with US Equestrian DR126 for level 1 competitions.
8. All classical dressage scores must be submitted to USDF regardless if competition management was provided with USDF numbers for the riders and/or horses.
9. Competition results must be submitted to USDF as a .dat or excel file via the USDF Electronic Results Submission Standard (ERSS) format (using the USEF Universal Spreadsheet Template) or the simplified blank results template provided on the USDF website by no later than 21 calendar days from the end date of the competition.
10. A \$25 fee will be assessed for late competition results.

## Horse Lifetime Points & Awards Program

### WDAA Horse Lifetime Points & Awards Program

The WDAA Horse Lifetime Points & Awards Program tracks points achieved by a horse throughout their Western Dressage career.

Points must be earned at WDAA recognized shows (find shows under Events on WDAA website)

Open to all horses, ponies, and mules regardless of breed, type, age, etc.

Points may be earned with more than one rider.

Owners and persons participating and/or riding a horse in the program must be current WDAA members in good standing.

Points awarded at all WD levels and Freestyle tests, as well as for rail classes.

WDAA World Championship Show test/classes earn triple points.

**USEF shows** with a USEF-licensed Western Dressage judge earn double points. Check the WD judge directory on the WDAA home page under "Important Links" to see whether your judge qualifies for double points.

### Program Fees

- Horse Enrollment Fee: \$100
- Annual Recording Fee: \$50
- Test Submission Fee: \$10/test or rail class
